May 15, 2017 Regular Session of the Beaverhead County Commissioners

The Board of Commissioners, in and for Beaverhead County, Montana, met in session on Monday, May 15, 2017 at 9:00 a.m. in the Commissioners' Room of the Beaverhead County Courthouse. Present: Chairman Tom Rice, Commissioner Mike McGinley, Commissioner John Jackson and Secretary Cindy Decker.

<u>Updates on County Projects:</u>

Road Secretary Jamie Flynn joined the meeting and Russ Sigman stood in for Scott Jones who is absent. County Attorney Jed Fitch and Scott Marsh joined the meeting as well. The crew has been blading roads steadily and has cleaned the sand off several roads in the county including 278 and Ten Mile.

Mike brought up the Pioneer Scenic Byway as far as it being closed. Russ said a large orange sign is posted now stating the road is closed approximately 12 miles ahead, also a sign on the Wise River side stating the road is closed approximately 12 miles ahead. Jed wanted to be clear that usually this time of year, the byway gets plowed but this year, it will not get plowed due to lack of funding from the Feds.

Scott Marsh handed out some colored maps of the area at Elkhorn/Polaris and discussed the Ordinance from 1992. The language of that Ordinance was discussed with the County Attorney's input and advice.

Russ suggested plowing up to the Fourth of July Campground. Much discussion ensued regarding four wheelers and side by sides.

Scott mentioned installing an unmovable gate for the winter.

The commissioners will contact the Forest Service asking for their input.

Also, Mike asked Jed if the county should issue an emergency road closure for that portion of the byway until it is drivable.

MOTION: Commissioner McGinley moved and Commissioner Jackson

seconded that there will be an emergency road closure approximately 12 miles from HWY 278 Pioneer Mountain Scenic

Byway Junction and approximately 12 miles from HWY 43 Pioneer

Mountain Scenic Byway until further notice.

Chairman Rice called for discussion.

Scott wanted it to be clear where the closure will be and it was reiterated from the motion.

Chairman Rice called for a vote.

A verbal vote was taken and the motion carried unanimously. Jed will draft an advertisement for the papers and radio explaining the reason the county will not be plowing the Pioneer Scenic Byway this year. A copy of the announcement can be viewed below:

Emergency Closure of Portion of Pioneer Mountain Scenic Byway

Due to the Federal Government's failure to fund the Secured Rural Schools (SRS), which is a large portion of the Beaverhead County Road Department budget, Beaverhead County will not plow the Pioneer Mountain Scenic Byway at this time. Please standby for updates.

The Beaverhead County Commission has enacted an emergency temporary closure of the road from the posted signs, approximately 12 miles up from both the Hwy 278 and Hwy 43 junctions.

The Beaverhead County Road Department has placed "road closed" signs approximately 12 miles ahead, near Hwy 278 and Hwy 43 junctions. Please observe these closures. The road will be opened when the snow melts naturally.
