

Howard Gaines Behavioral Health Community Service Award

The Beaverhead County Mental Health Local Advisory Council (MHLAC) desires to recognize contributions made by Beaverhead County residents who advance the cause of better behavioral/mental health in our community. To do so, this year the first annual award will be given to an outstanding Beaverhead County resident who has made significant contributions in this area. The recipient will receive a plaque honoring their achievement. The award is open to mental health professionals and community leaders who support and enhance the mental wellness of our County.

This award honors Howard Gaines, a tireless advocate of mental health for over 20 years. Howard Gaines was one of the first members of the Beaverhead Mental Health Local Advisory Council and the Western Service Area Authority. Howard died in 2016. His service to the community has been recognized by a Proclamation of the Beaverhead County Commissioners and the MHLAC establishment of the **Howard Gaines Behavioral Health Community Service Award**.
