


#### Q1: What area of the County do you reside in?




### Q7: Some rural areas in the County would like to protect their rural character and while still growing in size. What is the best way to achieve that balance in the future? (Written Comments)

- Unlimited growth is not sustainable without regulations. A free market approach would assume selling all property and development to the highest bidder. Areas like Polaris are particularly susceptible to this sellout, where inflated housing prices are creating a resort community. The resulting inflated socioeconomic standards of the community create higher taxes for the surrounding farms and ranches, whole also supporting a community whose financial resources are independent of the local economy. This discrepancy of housing inequality negatively affects those who work and need to live in an area, but can not afford it. Tax incentives are the only way to curb external money from buying out Montana and disparaging our workforce.
- Involve constituents in planning development of their communities
- Protect dark skies from things like flashing neon signs, upward facing yard lights, etc.
- Its impossible to growth and stay the same as you were.
- It is not possible to grow and retain our character.
- Quit promoting the B-D Forest. Its a zoo.

#### Q10. Is there anything else you would like to share with the County Planning Board about living and working in the County?

- We need big store back like shopco.. But not shopco..
- As previously stated, unlimited growth is not sustainable without proper infrastructure. I am particularly concerned about the housing crisis occurring across Montana and the country. Inflated housing market prices are displacing the current workforce. The average home price in Dillon is one quarter of a million dollars (\$250k). The average income in less than \$15/hr. City and county planning must take action to support the workforce and those who actively contribute to the economy. Perhaps those who own multiple properties or out-of-state should be taxed at a higher rate? Perhaps large properties should not used exclusively as a tax write off for the wealthy? Perhaps corporations should not be allowed to buy ranches? If Montana culture claims to support "our rural way of life," then how we grow and who our government supports needs to reflect that. Additionally, growth is not synonymous with being beneficial to all. Frequently small towns will make a push for increased tourism, growth, etc. and this has led to strains on the system and infrastructure. Be careful what you ask for.
- I think it's important for the county and city entities to work together for positive impact. The city has gone backward over the last few years with the current administration.
- Upgrade bridges and roads
- View the problems with collage students not living on campus. Our streets and bridges need help!!!
- Bring in a major retailer like Target and it will create jobs and attract more businesses and thus more people.
- The schism between the university and the larger community has become more apparent over this last six months, with many community members blaming the university for the unilateral rise in CV-19 cases. It would be appreciated if both communities could work together on this a bit!
- Assure that there are gun free zones (schools, church's, city and county buildings)
- Keep us Montana. We are not California.

- Yes, please request Minerals Technology of Pennsylvania to fund the paving of the Sweetwater County Road from the Sweetwater Subdivison II to their talc mine (including Carter Creek and Nisson Lane to Hiway 41). This county road system is heavily traveled each day and night; consequently, it quickly becomes very dangerous (even after the county's continual maintenance) due the heavy semi and truck daily traffic (night and day). Our county should not bear this cost when Barrett Minerals has numerous employees working several shifts, day and night, in addition to the various service and delivery semi's and trucks daily using this road. Eventually someone will pay the ultimate price for this inadequate road with heavy day and nighttime traffic. Thank you for bringing this important request to the Planner Board members and the County Commissioners.
- Development should be easier in town and that would curb urban sprawl to a point.
