## <u>Discussion & Action ~ Proclamation of National Dispatch Week</u>

Sheriff Paul Craft, Dispatchers Yvonne Phillips, Zack Haggard, Christina Cooley, Jack Wiggins, Elida Wheeler and Brian Judge, Chief of Police Don Guiberson, Deputy Clerk & Recorder Kodi Laird, Casey Elliott from the Tribune and County Attorney Jed Fitch joined the meeting.

Chairman Jackson read the Proclamation aloud.


After brief discussion, the following motion was made:

MOTION:

Commissioner Rice moved and Commissioner Jackson seconded that the Proclamation to honor our local dispatchers during the week of April11 – 17, 2021 be approved and signed. A verbal vote was taken and the motion carried unanimously.

WHEREAS,	in fact, there have been incidents in which public safety telecommunicators, recognizing the sound of a racked shotgun, have prevented serious harm or death of law enforcement officers who would have otherwise walked into a trap; and
WHEREAS,	the work of public safety telecommunicators comes with an extreme emotional and physical impact that is compounded by long hours and the around-the-clock nature of the job; and
WHEREAS,	research has suggested that public safety telecommunicators are exposed to trauma that may lead to the development of posttraumatic stress disorder; and
WHEREAS,	recognizing the risks associated with exposure to traumatic events, some agencies provide critical incident stress debriefing teams to lessen the psychological impact and accelerate recovery for public safety telecommunicators and first responders, alike; and
WHEREAS.	the federal Standard Occupational Classification System is designed and maintained solely for statistical purposes, and is used by federal statistical agencies to classify workers and jobs into occupational categories for the purpose of collecting, calculating, analyzing, or disseminating data; and
VHEREAS,	the federal occupations in the Standard Occupational Classification System are classified based on work performed and, in some cases, on the skills, education, or training needed to perform the work; and
VHEREAS,	classifying public safety telecommunicators as protective service occupations would correct an inaccurate representation in the Standard Occupational Classification System, recognize these professionals for the lifesaving work they perform, and better align the Standard Occupational Classification System with related classification systems.

He said that Beaverhead County is covered pretty well now as far as radio communication. Paul has been getting the jail ready for the upgrades.

Facilities Manager Chris Booth stated he is waiting to hear back from Longie Builders about the patio. He is most likely waiting for warmer weather to pour concrete.

Jed mentioned that he had a good meeting last week with attorney Thorin Giest and he will be taking about 14 or 15 cases. Jed has also spoken with Jacy Suenram about the possibility of taking some of the misdemeanor cases.

He complimented Barrett's hospital on their fine assistance through his ordeal. Jed will be undergoing some more tests in the near future to get a final diagnosis and the commissioners wish him the best.

## Discussion & Action ~ Recommendation from Hiring Committee for Museum **Director**

Mary (Candy) Whitworth, Neal Strauss, Michele Steven-Hassard, Lynn Giles and John Garry joined the meeting. The hiring committee has conducted a search for candidates and has interviewed 5 candidates. The committee and the Board recommend hiring Mary Whitworh as the Museum Director. Neal said they are still waiting for the results of the background check however.

After brief discussion, the following motion was made:

MOTION:

Commissioner Rice moved and Commissioner Jackson seconded that Mary (Candy) Whitworth be hired to fill the vacant position of Museum Director pending the results of an acceptable background check. A verbal vote was taken and the motion carried

unanimously.

Unfinished Business/Other Topics of Discussion

Dillon residents Archie Hayden and Bill Mancoronal joined the meeting to ask about the borrow ditches on Schuler and Laknar Lanes. Bill expressed concern that since work has been done on them, the water won't drain effectively. He feels that it will be detrimental to the road bed.

Archie asked the commissioners why they are having those ditches filled. Commissioner Rice replied that public safety is a concern. He also stated that he will head out there and take a look for himself.

At 3:00 p.m. Karl Yakowich from Great West Engineering called to discuss options for the FLAP grant; the Byway repaving versus work being done on Hwy 324. Tom advised that he left a message with Andy White (MDOT) but hasn't heard back yet. He also asked if it is about 47 miles of pavement on the Byway to which Karl replied yes about that. It would need to be determined if it would warrant a chip seal or an overlay. John commented that it should probably be chip sealed especially if it wouldn't get done for at least another five years.

Karl advised it would probably be between 1 and 2 million dollars to chip seal 50 miles of road and 4 million for an overlay; the county match would be \$260,000 for 2 million. He also advised that the Feds want more CIP type projects instead of maintenance. They want reconstruction or new construction projects for the FLAP grants. Karl encouraged the commissioners to speak with Andy White (MDOT) and get some advice from him as well.

Routine matters occupied the attention of the Board for the remainder of the day.

**Payment of Invoices** 

The Commissioners reviewed and approved invoices for a total of \$60,631.89, beginning with check #206936 and ending with check #207011. The Invoice Payment Schedule is located in the Financial Administrator's Office.
