# May 3, 2021 Regular Session of the Beaverhead County Commissioners

The Board of Commissioners, in and for Beaverhead County, Montana, met in session on May 3, 2021 at 9:00 a.m. in the Commissioners' Room of the Beaverhead County Courthouse. Present: Chairman John H. Jackson, Commissioner Mike McGinley and their Assistant Cindy Decker. Commissioner C. Thomas Rice was absent dealing with funeral plans for his son. Our condolences continue to be with his family.

# **Updates on County Projects**

Road Supervisor Bob Ferris and Public Works Secretary Jamie Flynn joined the meeting. Bob will go take a look at Carrigan Lane this week to see when is a feasible time to fix it. Jamie mentioned that she sent the bid advertisement to the Tribune for the Byway Striping and construction on Rock Creek Bridges to be advertised the next three weeks. We did receive a striping bid last Monday but it was after the meeting that it was received. It showed up late that night so it must be rebid on May 24<sup>th</sup>. The delineators will be an add alternate to the bid.

GIS Coordinator Tracy Sawyer, DES/Land Sanitarian Tom Wagenknecht, Casey Elliott from the Tribune, Facilities Manager Chris Booth, Sheriff Paul Craft, County Attorney Legal Assistant Montana Mantei, Victim Advocate Kayla Patrick and Attorney Jacy Suenram joined the meeting.

Chris stated that West Electric performed the beginning of the year inspection on the heating and cooling system in the Treasurer's Office and it is good to go for another year. He is waiting for the weather to cooperate to build the patio.

Tracy stated that the propane tank at the Kona site needs to be emptied and retrieved.

Tom stated that there is a person in Wise River that is irate about the canister site up there. The campers fill the canisters up so there is no room left for the residents' trash. Tom also mentioned that the Forest Service wants to donate a small trailer house to the county. Discussion ensued.

Paul commented that the parts have been ordered for the Butler Repeater Site so hopefully he can move forward as soon as those parts come in. He has gotten the bid for paint in the jail and has done a walk through with the plumber and is waiting on the estimate. Paul is ready to put two new trucks into service very soon.

# <u>Discussion & Action ~ Resolution 2021-11 ~ Appointing Prosecution Services to Assist Beaverhead County</u>

Jennifer Adkins from the Attorney General's office, Prosecuting Services Bureau Chief Dan Guzynski and Attorney Thorin Giest joined the meeting (via zoom). Dan began the discussion by explaining the reason for this Resolution. Beaverhead County Attorney Jed Fitch will be undergoing some serious medical procedures and will not be available to do his normal duties for an unknown period of time. The Montana Department of Justice has a bureau called Prosecution Services Bureau that exists for situations like this. Their field of expertise is criminal prosecution. They would take over our criminal Felony prosecution cases and would oversee everything in this jurisdiction. The Department of Justice would pay for everything except for trial expenses (expert witnesses etc.) so this comes at virtually no cost to the county.

Dan recommends that the county does need an interim county attorney until we know more about Jed's situation. He recommends Thorin Giest since we really need "boots on the ground" here locally.

The Yellowstone County Attorney has volunteered to take on the Youth Court Juvenile cases and Montana has already sent the cases to him.

The DN cases will be handled by Prosecution Services.

The Misdemeanor cases may be handled by Jacy Suenram or possibly Russ Michael. A decision will be made next Monday when we know more.

The Civil cases would need to be contracted by a local firm.

Thorin commented that he is a long-time friend of Jed's and is happy to help in any way he can. He also said that Jed is particularly well liked among the Bar and Prosecutors so there are a lot of attorneys that would step in to help and most would do it without charge; we have resources.

Paul suggested that we go by Dan's plan, lay out the groundwork and go on from there.

After brief discussion, the following motion was made:

seconded that Resolution 2021-11 ~ Appointing Prosecution Services to Assist Beaverhead County be adopted. A verbal vote

# Appointing Prosecution Services to Assist Beaverhead County

Whereas, the Beaverhead County Commissioners have requested legal assistance on behalf of the County for a period of six months from the date this Resolution is signed, or unless terminated earlier by the County Commissioners, and

Whereas, it is desired and deemed appropriate that special deputy county attorneys be appointed to assist Beaverhead County with its prosecution needs for the aforementioned period of time, and

Whereas, Mont. Code Ann. §44-4-111 authorizes and contemplates that the training coordinator for county attorneys and the bureau chief for Prosecution Services Bureau (together with the deputies within said bureau) act as special counsel on request of the county attorney and upon the approval of the board of county commissioners, and

Whereas, Mont. Code Ann. § 2-15-501(6) authorizes the Attorney General to provide assistance to county attorneys in the discharge of his or her duties, and

#### It Is Hereby Resolved:

That the attorneys assigned to the Prosecution Services Bureau of the Department of Justice are hereby appointed as special deputy county attorneys for Beaverhead County for the purpose of assisting in the prosecution of criminal cases as needed during the aforementioned period of time, and that any of said deputies can fulfill the functions set out in Mont. Code Ann. § 44-4-103.

If the need for assistance goes beyond the expiration of this resolution, the needs shall be addressed in an additional resolution at that time.
