# June 21, 2021 Regular Session of the Beaverhead County Commissioners

# **Updates on County Projects**

Road Supervisor Bob Ferris and Public Works Secretary Jamie Flynn joined the meeting.

Facilities Manager Chris Booth, GIS Coordinator Tracy Sawyer, Fire Chief BJ Klose, Surveyor Travis Wilson and Casey Elliott from the Tribune joined the meeting. Chris stated that part of the patio pad was poured this morning. He also mentioned that a quote was emailed to the commissioners for the storm drain. Also, West Electric submitted a quote for the air conditioning for the communication shed. Chris emphasized the importance of getting that shed cooled off during the hot months. Tracy stated that there is a legal issue on the road behind the Battlefield. The Forest Service is dealing with it now. A landowner has placed a log across the road. Fire Warden Tom Wagenknecht joined the meeting. He stated that it would be a good idea to implement the policy of "no open burning, but people can still have a fire in a contained fire ring". Tom is concerned about the afternoon winds.
