The Board of Commissioners, in and for Beaverhead County, Montana, met in session on July 6, 2021 at 9:00 a.m. in the Commissioners' Room of the Beaverhead County Courthouse. Present: Chairman John H. Jackson, Commissioner Mike McGinley, Commissioner C. Thomas Rice and their Assistant Cindy Decker.

Updates on County Projects

Road Supervisor Bob Ferris and Public Works Secretary Jamie Flynn joined the meeting. The crew has been busy blading roads and they took down the weight limit signs for the season. They will do mag chloride next week.

The crew will head up to Kona to remove the cement tower pillars in the next week or so.

Facilities Manager Chris Booth joined the meeting. He stated that hopefully the air conditioner for the County Attorney's office will be done today. He also spoke with Johnson controls regarding installing cameras outside the Treasurer's Office.

GIS Coordinator Tracy Sawyer joined the meeting.

A Public Hearing concerning the New or Expanding Industry Classification Application came on at the predetermined time and place pursuant to notice duly given. Zach Genta and Dustin Thompson from Clenera called in via conference call. Casey Elliott from the Tribune joined the meeting.

Zach began the discussion and gave a brief description of the project. He is hoping that the project will begin in March of 2022. It is located on private land out by the landfill. There will be a decommissioning bond provided and will be submitted to the MT Department of Environmental Quality prior to the conclusion of the 15th year of operation. Dust abatement will also be provided.

Casey asked if anything has changed substantially with their proposal from before other than the fact that they are seeking the qualifying facility designation. Zach replied that everything is the same about the project. The only difference is that this time, in accordance with some of the new legislation, they are seeking the Class 8 Tax Designation.

Myrna asked where the water will come from for dust abatement. Dustin replied that there is a water hydrant right there on the land that uses city water. Mike wanted it to be clear that only one plant will be built initially.

Reconvene Commission Meeting

<u>Discussion & Action ~ Tax Abatement for Clenera Solar</u>

Dillon residents Annie Rorabough, Justin Hildreth and Myrna Carpita remained in the meeting. Zach and Dustin remained on the phone for this agenda item.

Tom stated that Class 8 is a 3% tax. John asked how much revenue would come to the county from these taxes. Mike replied that it would stabilize everything as the county's revenue can only go up by so much. It would reduce the mills for everybody else. The county government does not just automatically "get rich" from this. The taxpayers across the county would be the ones to benefit.

After brief discussion, the following motion was made:

MOTION:

Commissioner McGinley moved and Commissioner Rice seconded that Beaverhead County *deny the abatement request* since it will be taxed at only 3%.

John called for discussion. Mike stated that the 3% tax is a fair number and he doesn't feel that there needs to be any additional tax relief. There is another solar farm coming to Beaverhead County that will be taxed at 6%; they may be granted a 50% abatement for the first ten years. Mike read some Montana tax codes aloud for comparison. He also commented that a resolution may possibly need to be adopted in the near future regarding this decision.

Chairman Jackson called for the question:

A verbal vote was taken and the motion carried unanimously.
